



President’s Message

As I begin my last 60 days as OLLI President, I’m reminded that change is constant—certainly at OLLI and this university.

Patsy Burns, our long-time chief staffer, retired. She wanted to continue until her replacement was on board, but circumstances prevented

that. In her 25 years of service to our organization, Patsy gave her all to grow our curriculum, increase membership, safeguard our finances and protect us from any adverse consequences of university personnel or policy changes. She is justifiably proud of what we have become.

I’m delighted the Board of Trustees made Patsy a lifelong honorary member. She follows in the footsteps of Betty Robertson and Harry Norman—the “godmother” and “white knight” of CSUF lifelong learning and extension education.

More change: In January, Dr. Debra Leahy, Dean of Extension and International Programs (EIP), was reassigned to focus exclusively on international programs—a critical global engagement and revenue-important university objective. OLLI was moved on the CSUF organization chart from the now-defunct EIP division to the CSUF Office of Academic Affairs.

At the top of the university hierarchy, the search for a new CSUF president is expected to be completed in the next 60-90 days. The new CSUF president will appoint a new provost (the university’s chief academic officer) later this year. The Provost heads the university division that includes OLLI.

Office Manager Patsy Burns Retires

After 25 years of service to OLLI at Cal State Fullerton as OLLI’s Administrative Manager, the venerable and beloved Patsy Burns has retired effective January 12.

OLLI’s Board of Trustees voted to award Patsy with a Lifetime Honorary Membership. In the above picture, Patsy (center) receives the certificate of Lifetime Honorary Membership from OLLI’s President Mike Stover and Vice President Membership Debbie Maxwell at OLLI’s Spring Preview on January 13.



I asked Mike Stover about his experiences working closely with Patsy during his two terms of office as OLLI’s president (2013-2015 & 2023-2024), and he said, “Every port with hazardous currents relies on navigational pilots; Patsy Burns was ours for 25 years. Patsy served my predecessors and me as OLLI Presidents as our eyes and ears about university issues and personalities that could either adversely or positively impact our classes and activities. She never hesitated to lay down the law to the occasional member who flouted campus policies. Still, my fondest memories are her candid comments about her heartfelt pride toward

Soon, Karen and the OLLI Board should be able to announce Patsy’s successor—a position with the rank of executive director with some enhanced responsibilities and authority within the CSUF hierarchy.

Speaking of change, the annual Board of Trustees election will be on April 18.

I believe that OLLI’s challenges and opportunities as we navigate our 45th year on this campus are best addressed by next generation leaders who work closely together to build on our post-pandemic successes while infusing new energy and ideas and finding and nurturing their successors.

Members nominated for the 2024-2026 OLLI leadership team by the Nominations and Elections Committee are outlined in this ChroniCLE edition. The ten members who are elected as officers and trustees will join eleven continuing Board members.

members aged 90-plus who built the organization they now share with us. I’m delighted the Board of Trustees agreed to make her a lifelong honorary member. She followed in the footsteps of Betty Robertson and Harry Norman—our founding ‘godmother’ and the long-tenured ‘white knight’ of lifelong learning and extension education at this university.”

Other past presidents also have fond memories of working with Patsy:

Past President Ellie Monroe (2021-2023) said, “I have known and worked with Patsy since 2010. In my early days on the OLLI Board, she spent many hours grooming me on the operations of OLLI and how the CSUF system worked. I became very knowledgeable about Campus Policies; the key staff in various business areas; the requirements needed to get supplies, reimbursements, complete contracts, risk management concerns, the key personnel in various functions of EIP and other campus businesses. As Treasurer, VP of Membership and Programs, President, and VP Programs again, she was essential in making things easier in getting my tasks completed. Many times, I watched her overcome barriers to get many of the business transactions completed for OLLI. She shared her experiences and ideas in order to accomplish many of the OLLI projects. Her influence on other campus offices cannot be replaced. She cared deeply for OLLI and she always went the extra mile to make sure we received what was needed to make us successful. During the COVID shutdown, Patsy spent several thousands of dollars of her own money paying invoices for OLLI purchases and contracts because of the shutdown of the accounting and financial systems during that time. She also paid the invoices for ceramic firing costs because the processing of the contracts at that time were not supported to allow OLLI to pay the invoices. She is to be highly commended for her dedication during the shutdown period for her efforts to keep some of the classes going at OLLI. She worked with Jim and I in keeping us informed and helping us get through a very difficult time in which the campus was not able to fully support OLLI’s operations. Once OLLI came back to campus, she was very

instrumental in helping several of us get reimbursed for the thousands of dollars spent to keep OLLI classes going. She has become a friend of mine and a wonderful advocate for OLLI.”

Past President Joyce Ono (2019-2021) said, “Patsy represented our OLLI well, she was so enthusiastic and proud of our OLLI and shared how unique we were when conversing with representatives from other OLLIs around the country. I recall when she parked her car at John Wayne Airport and drove me home to Fullerton, even though she lived at the beach. She was attending a birthday party that evening for past OLLI President, Barbara Talento, and wanted to find a Sees Candy store. I knew where the Sees store was in Fullerton so we went there first before she dropped me off. She wanted to buy Barbara a gift, AND, I discovered, she also wanted to get some dark chocolate for herself and some goodies for the office staff. This is when I learned about her ‘obsession’ for dark chocolate. Ever since then, whenever I brought goodies home from Hawaii, I always made sure to bring Patsy a box of dark chocolate covered macadamia nuts.”

Past President Jim Monroe (2017-2019) said, “In all my years in business and other community organizations, I have rarely met anyone with the dedication, passion, and commitment that Patsy Burns exhibited every day in her position as OLLI-CSUF Manager. She was extremely proud of this OLLI that she and others have created over the years. She demonstrated her commitment to its success in her work every day from guiding new volunteers like myself, to working through the university bureaucracy to achieve OLLI goals, within university policy and procedure. A few years ago, OLLI identified individuals as “Legends of OLLI”. I believe Patsy Burns exhibits the same qualities and commitment as these Legends and will be remembered with the founders and super volunteers who have made OLLI-CSUF what it is today.”

Past President Barry Escoe (2015-2017) said, “Patsy was fun to work with when I was President of OLLI. She was a character; she would call me ‘Hey Guy!’ I liked that she was always open and friendly to staff and OLLI members. She was a

dedicated manager, who spent long hours assisting the OLLI officers and office staff completing endless university documents and board minutes. She did not beat around the bush and took care of business. When something needed to be done, she did it. She was dedicated and kept OLLI going in the right direction.”

Past President Dave Musante (2009-2011) said, “Patsy Burns helped me tremendously in my early days as President of OLLI. Patsy helped me put together a promotional campaign to reach 1,000 members during my presidency. As a successful result to reaching 1,000 members, the Bernard Osher Foundation awarded a second one million dollar grant to Cal State Fullerton for OLLI. OLLI has been able to use the proceeds from this grant to enhance its yearly budgets.”

Two-term Past President Barbara Talento (2001-2003 & 2007-2009) said, “Patsy Burns was a terrific office manager, and CLE and OLLI were lucky to have her. But my best memory about her was out of her office. She is a very independent and generous person. When we went out to eat, she would always try to get the check. Which leads to this story. Patsy fell at her home and broke both of her knees. She was discharged from the hospital to a rehab assistive-living home. It was very expensive and not covered by insurance. She refused to accept any offers of help. We decided to try a different way. So, OLLI bought a giant piggy bank and put it in the coffee area with a note saying it was for Patsy. Within a couple of weeks OLLI members had filled the pig with \$4,000 plus dollars. When she got the pig, she was overwhelmed and couldn’t turn it down because there was no single person to return it to—a great memory about a hardworking, deserving and affectionate Patsy Burns.”

During my 12 years on the Board of Trustees. I’ve always been impressed with Patsy’s ease in dealing with people, both one-on-one and in front of a large group. She is authoritative without being threatening and a model of civility. And she always, always leaves you with a joke and a laugh.

I think I speak for everyone at OLLI who knows her that we look forward to seeing her on campus attending OLLI’s great courses and especially our social programs as a lifetime member.

Vehicle Parking Permits

We should all be aware of the new CSUF parking permit process, aka License Plate Recognition (LPR). Under the new LPR, plastic hangtags and paper permits are no longer issued. Your license plate is your permit. The LPR system relies on a license plate for permit verification. OLLI members MUST ensure the correct license plate information is provided in order to avoid a parking violation. The LPR process says you can have multiple vehicles. However, OLLI members, like students, are allowed only one (1) vehicle and two (2) exemptions/month. OLLI members who need to swap their vehicle for the day or longer (e.g. you have a rental) may request a daily exemption. You will need to contact Parking and Transportation at 657-278-3082 and provide a CWID, make, model, color of the vehicle, and license plate number. Once the rental vehicle is returned, be sure to contact the Parking Office. Take note, only one vehicle is valid on campus per day; additional vehicles parked on campus either associated or not associated with a virtual permit may be subject to a parking violation

What if I have temporary plates?

Temporary plates may be registered by entering the temporary plate number as the Vehicle License Plate. In your campus parking account, select “Temporary Plate” as the Vehicle Plate Type and enter the full VIN.

If there is no temporary plate number, enter the last 7 digits of your VIN as the Vehicle License Plate. Select “VIN Number” as the Vehicle Plate Type and enter the full VIN.

I thought I understood the workings of the new LPR process, but then I received a warning citation (not a ticket!) for having parked a car without a valid permit. You see, I recently purchased a new vehicle, hence a new license plate. I faithfully updated my new vehicle information with the permanent plate in my campus account on the CSUF Parking Portal and thought I had complied with the LPR requirements. So, I was surprised when I was leaving Lot J and noticed a CSUF Parking Ticket tucked inside my wiper. Needless to say, I was confused and upset, but then I realized the ticket was only a warning and there was no associated fine. The reason for the citation, “no valid CSUF OLLI permit on file.” But, I did update my account with the new vehicle, how could there be no permit on file?

Well, turns out there are two steps to the LPR process to update your vehicle information, and I had only completed Step 1. If you visit <http://parking.fullerton.edu/lpr/Default.php> you will land on Parking and Transportation Services web page that explains the LPR process. If you scroll down to the “Frequently Asked Questions” section and click on “What if I get a new license plate?”, you will see instructions telling you to first go online to your parking account and update your vehicle information. Then comes Step 2, “residents and students (which OLLI members are) must submit a Vehicle Change Request Form (it’s a hyperlink on their site, so simply click on it and you will be taken to the form). This is the step I failed to complete and therefore my parking account had the new vehicle, but it was not associated with a valid permit. The previous vehicle was still associated with the permit. Don’t assume like me that the LPR process will automatically remove the previous vehicle.

On the Vehicle Change Request Form, you can clearly see the two steps required when you need to add a new vehicle to your parking account. You will again specify the new vehicle information and then you must specify to remove the existing (i.e. previous) vehicle.

In retrospect, I failed to fully understand the LPR process and it almost cost me dearly—actual tickets are \$80, not cheap. You have been warned.

We will move to the Hallberg Theatre at Clayes Performing Arts Center for the “Accidentally on Purpose” performance at 2:00 p.m.

Devised Theatre is defined as “integrating aspects of theatre, film, design, music, performance art and merging technologies.” Students conceive, design, direct and perform highly athletic, visually stunning, interdisciplinary projects that shape today’s evolving theatrical landscape. The Clayes box office is open Tuesday–Friday, 12:00-4:00 p.m. with 15-minute parking at the end of Arts Drive. OLLI members get discounted theatre tickets, so show your OLLI tag.

Spring Preview Event Held

On January 13, OLLI’s annual Spring Preview event was held at the Ruby Gerontology Center.

Unlike other Spring Previews, recruiting new members and retaining members was a priority. Advertising was done in community newspapers and internal communications offered incentives. President Mike Stover happily observed that the turnout for the Spring Preview was beyond any past Spring Previews in his experience. The impressive registration numbers appear to support Mike’s impression: as of the date of this writing, 73 fall-only members have renewed and 105 new members have joined OLLI.

There were no program information booths, as are usually provided at OLLI’s Open House events, but curriculum information and Q & A tables were set up in Rooms 8, 9, 19, 21 and the Shapiro Wing for potential new members.

The program given in Mackey Auditorium started with a recorded welcome from CSUF EIP Dean Debra Leahy.

President Mike Stover then talked about OLLI’s history and relationship with Cal State Fullerton, how OLLI is organized including our reliance on volunteers and our relationship with the Bernard Osher Foundation. He also announced this event kicks off the 45th Anniversary of OLLI at CSUF.

Vice President External Relations Bob Kovacev talked about the advantages of joining OLLI, including what they can learn, making new friends, travel opportunities, giving back to the next generation and finding “a place to belong.”

Mike then went over the highlights of the program offerings for the spring semester, directing the audience to the publications handed out when they signed in and information rooms set up for the event. Finally, OLLI’s 90+ Club members, those over age 90 who are given honorary membership, were lauded for their longevity and service to OLLI.

Three New Courses Added to the Spring Semester Curriculum

An Insider's View of an Oft-Misunderstood Segment of Society

This course is based on Dr. Pauline Merry's memoir which shares her insights of growing up in segregated St Louis from the ages of 5 to 17. The memoir will serve as the starting point for class discussion including the social and historical perspective from her point of view and how Dr. Merry surmounted racism and ignorance with grace and grit. Class topics: January 24 - Introducing the Black Middle Class; February 7 - The Ville in St. Louis MO, home to working- and middle-class blacks of the '40s and '50s. including an introduction to growing up during this period in Ville, St. Louis; February 21 - The memoir continues with five stories of a little black girl growing up in the very segregated St. Louis, Missouri.

Instructor Dr. Pauline Merry and Coordinator Grace Alexander will offer the course on Wednesdays, January 24, February 7 and February 21 from 11 a.m.-12:30 p.m. in Room 9.

Beginning Fly-Fishing 101

This course is designed for individuals who have little or no fly-fishing experience and are interested in developing the basic skills necessary to fly-fish for trout confidently. We will start with equipment selection and setup and continue through the fly-fishing techniques needed for a successful day on the water. There will also be discussions on wilderness safety and environmental stewardship.

Required Equipment: Fly rod, reel with backing, fly line and tapered leader

Suggested Reading: "The Curtis Creek Manifesto" by Sheridan Anderson (\$9-12 online)
Prerequisites: participants must attend classes in Room 9 to attend field trip sessions at Laguna Lake. No California fishing license is required.

OLLI's Distance Learning Program

Since 2017, Bob Newcomb's intrepid team of 23 OLLI members and CSUF student workers have recorded and technically enhanced more than half of OLLI's classes. In the past year, 259 classes were added to the video library. Following are highlights from OLLI's Board of Trustees meeting on January 11, 2024:

- Members who anticipate needing reimbursement for OLLI expenses must confer with OLLI Treasurer Vickie Hite in advance to assure all CSUF requirements are met.
- Administrative Manager Patsy Burns retired January 12. For now, all non-financial issues will go to President Mike Stover and all financial issues will go to Treasurer Vickie Hite.
- Lifetime Honorary Membership was approved for Patsy Burns for her dedication and service to OLLI. She is expected to continue coming to campus as an active member.
- As of January 11, membership totals 1,042, including 221 new members.
- Spring semester starts January 16, and parking permit enforcement starts January 18. The OLLI office and VP Administration Bill Sampson are ready to help with any Omit Parking validations to avoid citations.
- OLLI Trolley will have a full schedule of service the first two weeks of spring with emphasis on Thursdays.
- Expenditure of the remaining membership advertising budget was approved.
- Bob Newcomb began developing OLLI's Distance Learning Program in 2017 by videoing classes, which expanded in 2020 to include Zoom and eventually livestreamed classes. There are now over 1,090 class videos in the Distance Learning library available for members to view. President Stover thanked Bob Newcomb and Jim Monroe and OLLI's technology team

and CSUF student assistants for this outstanding work and amazing outcome.

- TitansGive, the one-day, principal solicitation of gifts to OLLI for the year, is coming in March.
- Vickie Hite gave recommendations from the Financial Advisory Committee for changes in financial reporting to the Board to improve transparency.
