OLLI-CSUF Board Election Coming April 19, 2018

In accordance with OLLI Bylaws, BL-8, the Nomination and Election Committee was tasked with nominating a single slate of candidates for election to replace the members of the Board of Trustees who are completing their terms in May 2018.

The Committee nominated Jim Monroe for President; Chris Shaw for Vice President Communications; Janice Jeng for Vice President External Relations; Joyce Ono for Vice President Technology; Linda Lockwood for Secretary and Kathryn Cozza, Joanne Hardy, Bill Sampson and Ann Sparks for the four Trustees at Large to be elected in April. The Vice President Administration position has no nominee. Short biographies and pictures of all the nominees are shown in this issue.

The Board of Trustees appointed the following OLLI members to this year's Nomination and Election Committee: Patti Chikahisa and Monica Broome (representing the general membership); Ben Chin and Jim Ertle (representing the Board); Barry Escoe (Immediate Past President); and Don Lake (Chair). Thanks to the Committee members for recruiting and vetting a fine slate of nominees.

In October and November of 2017 all OLLI members were invited via emails, OLLI News Bytes and the ChroniCLE to submit an application to the OLLI Secretary if they were interested in becoming a candidate to replace the outgoing officers or trustees. Those applicants and other OLLI members were considered by the Committee for the Board positions up for election. Their deliberations were confidential and independent of the Board.

Bylaw 8.4 also provides: "In addition to the



Proposed Amendment to OLLI's Bylaws

As time goes by OLLI-CSUF's practices evolve, and our Bylaws need to be amended.

The Board of Trustees has approved an amendment to the Bylaws, and OLLI members will be asked to approve it during the General Meeting and Election on April 19. Many of the changes involve updating titles, correcting grammar and formatting, removing archaic references and moving details to better-suited Policies or Procedures documents. It's been 10 years since our Bylaws were last amended.

The job of overseeing our controlling documents falls to the Policies and Procedures Committee, Phil Barnhard, Lee Ann Donaldson, Barry Escoe, Nancy Hill (UEE consultant), Jim Monroe, Joyce Ono, Chris Shaw (secretary) and Mike Stover (chair), who recommends amendments to OLLI's Board of Trustees. Once the Board approves an amendment, our Constitution requires it to be approved by OLLI's general membership.

The substantive changes are:

- Formalize the practice of the OLLI President to temporarily add to officer duties in response to evolving priorities, workload and challenges.
- Realign officer responsibilities to be in accordance to changes approved on March 9, 2017 by the Board Executive Committee.
- Formalize the Board Parliamentarian position, appointed by the President and ratified by the Board, as described in the OLLI Policies.
- Formalize changes made to OLLI's
 nomination and election process begun in
 2016, providing procedures for the Secretary
 to solicit applications from members for
 Board positions, and procedures enabling
 applicants who are not nominated by the
 Nomination and Election Committee to be
 nominated by petition.
