The Ease, Simplicity and Power of Bequests and Beneficiary Designations

In April 2017, OLLI-Sonoma State announced it had received a bequest of \$2 million to grow OLLI activity at Sonoma State. SSU-OLLI Director Carin Jacobs said in a statement, "The boomers are coming to class in growing numbers, and Gen X is right behind them," referring to the older waves of students. "This bequest will allow us to grow and adapt to meet the needs of these new generations of OLLI students." [The Press Democrat, April 28, 2017]

Bequests are one of the most common forms of planned or deferred giving. Another form, right up there with bequests, is the beneficiary designation. A bequest generally involves a set of instructions in your trust or will for the disposition of the assets comprising your estate. Beneficiary designations are even more simple and can sometimes be more tax-wise by preventing assets from going into your estate, whether your estate is taxable or not.

Increasingly, investors have the opportunity to name beneficiaries directly on a wide range of financial accounts, including employer-sponsored retirement savings plans, IRAs, brokerage and bank accounts, insurance policies, U.S. savings bonds, mutual funds and individual stocks and bonds.

The upside of these arrangements is that when the account holder dies, the monies go directly to the beneficiary named on the account, bypassing the sometimes lengthy and costly probate process.

It is important to work with an estate planning professional to ensure coordination between your beneficiary-designated assets and the disposition of property as it is spelled out in your will.

You should also review your beneficiary designations on a regular basis—at least every few years—and/or when certain life events occur, such as the birth of a child, the death of a loved one, a divorce or a marriage, and update them, as necessary, in accordance with your wishes.

Are you a longtime beneficiary and supporter of OLLICSUF? Perhaps you have been thinking about how you could make a significant gift to support our work.

Many retirees think about leaving IRAs or other qualified retirement accounts to their heirs. Since qualified retirement accounts receive tax-preferred treatment as they grow, your heirs may pay estate taxes and income taxes on the qualified retirement accounts.

There is a more tax-wise strategy. By designating OLLICSUF as a beneficiary of qualified retirement assets, you can still provide a nice inheritance to heirs with other parts of your estate while avoiding the income tax!

Contact your IRA or 403(b) custodian to obtain a beneficiary designation form and name OLLICSUF as a beneficiary of your IRA or 403(b).

On October 24 Susamma Barua, Ph.D., Interim Dean, College of Engineering and Computer Science (ECS), will provide an overview of



programs offered by ECS and speak about its role in related workforce development.
Listeners will learn about exciting ECS student success initiatives to increase student retention and reduce their time to degree. Dr. Barua will talk about student engagement through faculty/

student research and industry and community partnerships. Finally, she will highlight past OLLI-CSUF Collaboration efforts and share ideas for potential projects.

Dr. Barua, who joined Cal State Fullerton in 1988, earned her Ph.D. in computer engineering from the University of Cincinnati. She has been active in mentoring female and underrepresented students in computing throughout her career. Undoubtedly, Dr. Barua's knowledge, enthusiasm and involvement in engineering and computer science will enable listeners to keep pace with the rapid changes and future directions in these fields.

On November 7 Laurie Roades, Ph.D., Dean of College of Health and Human Development,



will share her expertise. Dr. Roades, a licensed clinical psychologist, has done research in gerontology, neuropsychology and more. She will enlighten us about new directions in the School of Health and Human Development, which includes

nursing, child and adolescent studies, kinesiology and counseling, to name a few. She joined CSUF in 2016, after 20 years as an associate dean at Cal Poly, Pomona.

Following the fall break, on November 28 Marie Johnson, Ph.D., Dean of the College



of Natural Sciences and Mathematics, will be the culminating fall speaker. Before coming to CSUF, Dr. Johnson spent 21 years at West Point, where she was the director of the Environmental Program for seven years.

World leaders today are focused on global warming and the environment. Dr. Johnson's research interests center on environmental security, an interdisciplinary field that analyzes how degraded environments cause chaos, conflict and violence in the world. Her insights will assuredly enlighten listeners about our fragile planet and the importance of training future leaders in the natural sciences and math. The College of Natural Sciences and Mathematics includes five departments—biological science, chemistry, geology, physics and mathematics.

Come early to these talks to grab a great seat in Mackey Auditorium. You'll be treated to four dynamic speakers as they tell "tales" about a great university—California State University, Fullerton.
