New leaders must be willing to do the necessary work to get the job done. Yet, I can assure the nextgen leaders that they will work with a committed team and have sufficient organizational and financial resources to succeed.

OLLI Board of Trustees Openings and Application Process

This is your chance to become part of managing OLLI. Each year approximately half of the officers and trustees at large on the Board of Trustees finish their two-year terms of office (one-year for the president), and new members are elected to replace them at the General Meeting and Election in April.

Following are the Board positions that will be up for election in April 2024:

• President—OLLI's chief executive officer presides over meetings of the Board of Trustees, Executive Committee and other meetings, implements decisions at those meetings and keeps OLLI's membership informed.

• Vice President Administration—Acts for the president in the president's absence. Responsible for supervising personnel, office support, parking, OLLI Trolley and Archivist/Historian operations.

• Vice President Communications—Responsible for supervising internal media, including the ChroniCLE, Blue Book, newsletters and other email announcements, website, social media, electronic bulletin board, event & member photographs and Digital Image Archive.

• Vice President External Relations—OLLI's liaison to CSUF is responsible for supervising research studies, grants, awards, speakers bureau, OLLI-CSUF Collaboration, long term planning, external publicity & relationships, and membership recruitment operations.

• Vice President Technology—OLLI's liaison to CSUF IT and responsible for supervising audiovisual and classroom support operations.

• Secretary—Prepares and distributes the minutes of the Board of Trustees, Executive Committee and general membership meetings, reports Board *OLLI Board...Continued on Page 3*

What Does a Trustee Do On the Board of Trustees?

To some it could seem like there is a "good ol' boy" network of the same people running the Board of Trustees year-after-year, but if that happens it's only by necessity when not enough new members step forward to apply.

The Board is very eager to get more applications from OLLI members who are new to the Board and new to OLLI. In fact, OLLI's Nomination & Election Policy states: "With due deference to long-time members, OLLI encourages a continuing reservoir of vitality. Experience on the Board is best ensured by considering new and recently retired members after they have become acquainted with OLLI."

Importantly, any OLLI member may apply to be a nominee for trustee at large (or any of the open Board positions, except president) simply by submitting an <u>application from the OLLI website</u>, or getting it from the OLLI office, completing the form and emailing it to Renee Cabrera, OLLI Secretary, at <u>rmcabrer@csu.fullerton.edu</u>.

OLLI at Cal State Fullerton was founded on the idea of community seniors banding together, volunteering their time and contributing their skills and knowledge developed over a lifetime, to provide a low-cost, no-tuition, perpetual college of lifelong learning for seniors. There are numerous opportunities for OLLI members to contribute their time and talent, from teaching courses to support services to managing the organization.

It is this last function, managing OLLI, that the Board of Trustees fulfills. There are 11 elected officers on the Board, including the president, eight vice presidents, a treasurer and a secretary. Their responsibilities are fairly obvious from their titles, but the Board also includes nine elected "trustees at large" whose responsibilities are not self-evident and are largely unknown by OLLI members. The most common question I get about OLLI's elected offices is "What does a trustee do?"

Trustees need no prior experience of any kind, making that position the easiest entry onto the Board. To apply for some officer positions, like treasurer, it's helpful to have accounting or other similar experience in your pre-retirement life. For vice president positions, it's helpful to have experience on committees that are supervised by that officer. All candidates for officer positions benefit from experience on the Board as a trustee.

Trustees learn by experience, learning how the OLLI organization functions and how the various officers manage their areas of responsibility. Specifically, OLLI's Bylaws direct the Board to promote the training of trustees at large for greater future responsibilities by assigning them to work with and assist officers on the Board. In this way, the trustee may become a potential candidate for an officer position in a future election. Trustees may also be asked to join operational analysis and planning committees.

Perhaps the trustee's most important job is to represent the interests of all OLLI members in Board meeting discussions and decisions on issues that determine OLLI's direction and how its resources are used to best serve OLLI's members. The title "Trustee at Large" means each trustee represents all of the OLLI membership, as opposed to any one person or group.

The Board of Trustees is the decision-making body of OLLI. As such, it is vital that it be regularly

longevity. For those who do, we are planning OLLI leadership information presentations and discussions to remove any "mystery" about the OLLI leadership service.

Don't hesitate to apply because you believe you do not know enough about OLLI and its processes. We'll teach you. After all, we are a lifelong learning organization. If you are interested in serving, please contact me at <u>stovermw@gmail.com</u>.

Five years ago, the OLLI membership approved bylaw changes and several OLLI Board of Trustees initiatives to enhance nomination and election transparency and attract a broader selection of potential leaders. These changes included:

• A one-page form for members to nominate themselves or others for OLLI officer and Trustee at Large positions: <u>https://tinyurl.com/olli-nominate</u>.

• Enhanced communication about leadership opportunities, responsibilities and the nomination process to heighten member awareness and stimulate nominations.

Since adopting these initiatives, the Nominations and Elections Committee has recommended more than 90% of the self-nominated members. Those not selected for the Committee's recommendations are often appointed to leadership positions in the ensuing year.

So, please nominate yourself or encourage others to step forward. The future of OLLI is literally in your hands.

Since my appeal for volunteers in the last two ChroniCLEs and the recent OLLI Today and Tomorrow Forum, I have received several offers of assistance.

Many members have discovered the rewards of volunteering for our well-respected OLLI-CSUF Collaboration program, which provides various onetime, short-term or ongoing opportunities to help CSUF students and assist campus faculty and staff.

However, some of our most urgent needs remain. These include more instructors and new class advocates, live streaming technicians, trolley drivers, publication designers, hospitality event organizers/helpers, news media publicists, researchers and seasoned MS Office or Google software assistants to help OLLI officers and project leaders manage their workload. Please be—or continue to be—an OLLI helper if you can. We need you.

• Trustees at Large (four positions)—Learn how OLLI functions and Board officers' areas of responsibilities: back up officers, serve on various committees and represent OLLI members' interests on the Board.

All OLLI members are encouraged to communicate their interest in being nominated for any of these positions by completing a short and confidential application form and submitting it to the OLLI Secretary, Renee Cabrera. All applications must be received no later than **November 15, 2023**.

All applications received will be considered by the Nomination and Election Committee for nomination. Applicants will receive further notification from the Nomination and Election Committee. Any applicants who are not nominated by the Committee may submit a petition to be added to the election ballot.

refreshed with new members joining in the process of discussing and deciding the myriad issues faced by the Board, like how to navigate the aftermath of the pandemic, as a recent example. New trustees are the principal source of new perspectives and ideas for the Board, often representing the interests and needs of incoming, younger generation members.

As are all officers, approximately half of the nine trustees' two-year terms of office end each year and are replaced by other members, who are elected by the OLLI membership each April. Applications for nomination for next April's election are being accepted now (see "Board of Trustees Openings" in this ChroniCLE).

OLLI Members Surveyed About Graphic Novels and Comics

Three OLLI members from the "Graphic Novels, Comics and More!" book club, Barbara Glaeser, Irene Bourdon, and Jill Patterson (pictured in that order), wanted to find ways to make our book club more interesting by finding out what OLLI members thought of this form of literature. Along with a fellow comic lover and amazing artist, Andrew Sanchez (pictured), we wrote a survey that asked members what kind of comics and/or graphic novels they read over the course of their lives and what they did or did not like about them. We also did a few follow-up interviews to get more in-depth viewpoints. A few older adults outside of OLLI were included as well. The team applied to present this research at The Comic Arts Conference at Comic-Con in San Diego, which hosts 100,000 attendees. We were accepted, and proudly presented our results July 22!

Results were very informative. We created a chart that graphically depicts the results that were gleaned from the survey and interviews. Eighty Eight percent of readers wrote that they liked the unique characters and plots in comics and graphic novels. An interviewee stated: "I enjoy the interplay of art and story. I like the different characters and the unlimited possibilities of the comic world (superpowers, different environments, and dimensions). I appreciate and enjoy studying the 'unwritten' of the storyline to fully understand the emotions and actions taking place in comics." Another found them easier to read. "With limited time, I find I can plow through graphic novels and informational graphic books much more easily and with sustained interest."

Sixty percent found graphic novels easier to read and enjoyed the interplay of art and story. For example, one told us: "I really appreciate the artwork. I have been taking some introductory art and drawing classes so I can appreciate the skill of the artist and the choices they make in terms of colors, pen strokes, etc." Conversely, those who said they preferred traditional texts found the art distracting and more difficult to read. One wrote



that he preferred to let his mind make his own interpretations of what the author is describing rather than have to look at detailed pictures on a page. They felt that "Because there are more of the illustrations and less text, more interpretation is required by the reader." and "In a traditional book, there is a definitive plot to follow which doesn't require the same degree of interpretation."

Interestingly, one interviewee said that the interplay of art and text helped her to learn to read. One respondent who has dyslexia reported that comics "... helps to clarify some things I can't understand due to learning disabilities. I liked, when I was a kid and had to do a book report, when I realized I get it in comic book form. I could understand it better, it made it more interesting, and I could keep up with the class and know what the teacher was talking about. The comic clarified a lot of the words, statements and ideas in a way I could understand."

From the bottom of our hearts, we want to thank the OLLI members who participated in our study and helped make it a success. Two of the five Ranganathan library laws are: Every book has its reader and every reader has her/his book. Our results showed us that most OLLI members read newspaper comics when they were young, and the things they liked about them then are now expanded into the diverse and complex graphic literature available today.

There is a graphic novel or comic for every reader and you may find yours by joining our class! Watch for our reading list in OLLI's weekly newsletters and drop in any time!

New Courses Added to Fall Semester Classical Geological Sites in North America and Europe

Rich Lozinsky, an Earth Science Professor at Fullerton College for 30 years, will take you along on his sabbatical journey in 2005 to visit classical geological sites in the Canadian Rockies and Europe. He began touring Alberta to examine mountain building processes and for key fossil localities. Then he went to Great Britain to study landscapes and to find Nessie in Loch Ness. Italy will include volcanic features near Naples and the processes that formed the picturesque Amalfi coast. In the Alps he studied the forces that uplifted this spectacular range and the glaciation that carved out the amazing peaks and valleys. His final stop was in the Burgundy area of France for a goodbye toast.

The coordinator is Ellie Monroe, and this oneclass seminar will be offered on November 7 at 10:15 to 11:45 a.m. in Mackey Auditorium.

News: Up Close and Personal

Instructor Mike Stover presents enlightening discussions of the day's news, including current events, entertainment, culture, technology, business, the economy, health and medicine, successful living, politics and law. Following are highlights from OLLI's Board of Trustees meeting on September 14, 2023:

• The Open House Organizing Committee is evaluating the 2023 Fall Open House with recommendations for 2024. The overall impression was Wow!

• Technical coordinators Jim Monroe and Tom La Casa were thanked for their special efforts in helping members to register since the Fall Open House.

• As of September 14, OLLI had 184 new members, and various efforts are being made to engage them in OLLI, including the New Member Orientation on September 16. Total membership is at 970 and another 50 or so are projected to join or renew before the start of the fall semester.

• CSUF's Annual Impact Report will spotlight OLLI's support, featuring the OLLI-CSUF Collaboration program.

• Implementation of the new virtual parking permits is a success with minimal challenges.

• Staffing and scheduling of the OLLI Trolley has been a challenge. More drivers are being recruited.

• Lot J has been filled to capacity on many days, reflecting that more members are returning to oncampus class meetings.

• Non-member guests must use the new Park Mobile online parking app to find and pay for parking spaces. Lot J is reserved for OLLI members and is not available to guests through Park Mobile. Special procedures are being worked *What's Happening ...Continued on Page 9*

out for OLLI's guest speakers.

• VP Programs Ellie Monroe is working to find ample space for classes that are over capacity.

• Instructors are encouraged not to change their class schedules from in-person to Zoom, because members don't always see the emailed notifications of change and show up to find no in-person class.

• The information table and morning coffee programs have been very successful.

• The Development/Philanthropy Committee is coordinating a fall fundraising appeal to members, principally through a letter from President Mike Stover to all members.

• President Stover gave an informational report and led a discussion with Board members on OLLI's fiscal and budget development and its relationships with CSUF EIP, ASC and Philanthropic Foundation to better understand how it all works.

• President Stover asked the Board officers to submit their Short-Term Plans for the remainder of the calendar year.

• Michelle's position in the OLLI office is vacant again, and hiring a replacement is a priority.

Get It From the Source: Options for Livestream Classes

A new OLLI member asked Mike Stover, President of OLLI, if they have a conflict and can't attend a class would it be available to view via online streaming later?

Many of our classes are available to attend via Zoom and some are recorded via livestream. See the Blue Book Schedule of Classes and Events for the fall semester. It will show which classes are offered on campus (indicated by a room number), which are offered via Zoom (Zoom) and which are offered via livestream (Stream). Classes may be offered in one of these ways, or you may have a choice of multiple ways to attend (Room 21/Zoom/ Stream).

Livestream gives you two options: 1. View the class online via a link at the time the class is held; or 2. View a recording of the class later through the same link. The links for both Zoom and livestream

for all classes that offer those choices are available directly through OLLI's weekly Class Information and Updates Newsletter and on the OLLI website at <u>Zoom links - Osher Lifelong Learning Institute</u> <u>CSUF (fullerton.edu)</u>. This website link requires your login through the CSUF student portal, so you'll need your CSUF username and password.
