OLLI-CSUF Survived the Pandemic Through Technology and Tenacity

There is no reason to celebrate the upcoming third anniversary of the campus shutdown in March of 2020, but it is important to acknowledge OLLI's resilience in successfully keeping our programs going in spite of COVID-19. I have identified key leaders here, but there were many members who contributed to what was a massive group effort.

As COVID-19 began to rage, OLLI's Board of Trustees decided to shut down all in-person activities on campus as of March 16, effectively canceling all programs for the remaining four weeks of the spring 2020 semester and the following intersession, including an extensive celebration planned for OLLI's 40th anniversary.

OLLI President Joyce Ono learned that Cal State Fullerton had contracted with a company called Zoom for an enterprise account enabling all students, faculty and staff to use this app and replace in-person classes with virtual videoconferences.

Some of OLLI's more tech-savvy instructors—Bob Newcomb, Fritz von Coelln, Russ MacKeand, Joyce Ono, Susan Hanna, Mike Stover, Judy Alter, Jim R Monroe, Janet Bratton, Linda Callen, Vickie Hite, Toni Hoffman, Jeanette Reese, Joanne Hardy, Claire Curran, Mary Sampson, Rick Hearn and Ellie Monroe—were early Zoom adopters. They learned how to host Zoom videoconferences, contacted their class members and continued their programs through the spring semester and into the intersession. Their experience would later prove helpful in designing the Zoom training for other instructors.

Effective March 25, 2020, the University shut down the entire campus and OLLI's office staff

Parliamentarian Phillip Barnhard

President Ellie Monroe appointed Phil Barnhard



as OLLI's Parliamentarian at the May, 2021 Board meeting, but this was nothing new. Phil has been appointed Parliamentarian every year since 2012, serving the last five presidents, which attests to the trust and respect he has earned in that position,

OLLI Bylaw BL-8 provides that a parliamentarian will be appointed by each OLLI president, and ratified by the Board of Trustees, for the length of the president's term of office to advise the president on the orderly conduct of business in accordance with policies and practices and interpret OLLI-CSUF's Policies, Bylaws and Constitution. Phil does a bit more than that.

Phil believes a good Parliamentarian should have a knowledge of OLLI's history and how OLLI and CSUF both work and interact. In making judgements, he considers OLLI's history and its routines of conduct in terms of both expressed and implied rules. Although OLLI's rules do not prohibit it, Phil believes that the Parliamentarian should not serve in any other Board position so they can maintain neutrality.

In addition to Board meetings, Phil is often invited to participate as Parliamentarian in a nonvoting capacity in meetings of other committees. He helps the committee chair keep to the agenda, ensures votes and discussions of motions are in accordance with Roberts Rules of Order and opines on procedural and operational rules. Beyond that, Phil regularly receives requests for opinions from officers and other OLLI members outside of official meetings. Actual legal issues must be discussed with the CSUF counsel, but Phil often serves as a sort of unofficial, independent "counsel" when inevitable controversies arise. As he puts it, "I'm Switzerland ... I get involved with an incredible variety of shades of gray."

Phil's background serves him well in this role. He was born in Columbus, Ohio but his family moved to California, and he graduated from Anaheim High School. He went to the University of Arizona, earning a B.S. in Agriculture, and obtained a J.D. law degree while working in the health industry. Although he never practiced law, his education helped him in his role with the California Jaycees and his jobs working for Blue Cross and other medical companies. While at Blue Cross, Phil created the second pre-paid health plan in California, called Communicare, which later became Health Net. He later became Chief Operating Officer of St. Johns Hospital in Santa Monica.

Phil was introduced to OLLI by his daughter, who had been a student at Cal State Fullerton. She paid for his first year's membership in 2009 and convinced him to become an active member to help him through a very difficult time caring for his wife through her final illness. The next year Barbara Talento convinced him to become a trustee on the Board, and he served as such for several years before being appointed Parliamentarian. Some years later, Phil met a new life partner at OLLI, and she renewed a purpose in his life. Phil says that OLLI saved his life—more than once.

were sent home. Three of OLLI's resident techies, Bob Newcomb, Jim Monroe and Bill Reilly, worked with CSUF IT to gain access to the closed OLLI office and obtain computer equipment for the office staff and arrange access to their CSUF email and voicemail accounts so they could continue to serve OLLI members from their homes.

President Programs Ellie Monroe and Jim Monroe reviewed OLLI's programs to determine which of them could be offered via Zoom. Some programs, like Poker and Tennis, just could not be replicated on Zoom. But most programs could—it would just require the will of their instructors and coordinators to do it. Ellie contacted each program's instructors and coordinators to convince them to learn how to host their programs online using Zoom. Ellie, Jim, Bill Reilly and Susan Hanna developed training materials and scheduled and presented online training of the instructors and coordinators to host Zoom classes.

Ellie noted, "Instructors deserve a lot of credit for the effort and time they put in to learn how to host their programs on Zoom and do it, rather than just giving up." It wasn't easy for them. Eventually Tech Coordinators were designated to control the Zoom system during class meetings, freeing instructors to concentrate on the program rather than the technology.

OLLI members, too, had to be taught how to use Zoom to participate in online classes. Bob Newcomb and Jim Monroe wrote instructions and recorded a video. These were published or promoted in the ChroniCLE, in the newsletters and on the OLLI website. Jim Monroe, Ellie Monroe, Joyce Ono, Richard McCaman, Susan Hanna and Rick Hearn conducted online workshops for OLLI members.

Board meetings resumed via Zoom on April 9. Starting April 18, only a month after the shutdown, intersession programs were offered to all members via Zoom, including five new programs initiated by Ellie Monroe that addressed emergency management and coping with the pandemic. Members were also encouraged to view OLLI's Distance Learning library of class videos of past classes on the OLLI website.

The OLLI General Meeting and Election needed

to go forward on April 16 in order to elect new members to replace half of the outgoing Board of Trustees members. Joyce obtained one of CSUF's few licenses for a Zoom webinar that allowed enough attendees to accommodate OLLI's membership.

The summer session started June 1, 2020 with an impressive 50 programs on Zoom out of the originally-planned 92 programs. Throughout the summer more and more instructors were trained and, as they saw other instructors' success on Zoom, they were inspired to restart their programs. Out of a potential 117 programs, 86 programs were offered on Zoom for the fall 2020 semester.

Joyce said about the whole effort to get online classes up and running, "I'm proud to say we really did a good job in a very, very short amount of time."

Long before the pandemic hit, Vice President Technology Bob Newcomb, with Don Lake, had envisioned livestreaming class presentations through the internet. During the shutdown, Bob and Jim Monroe set about obtaining funding from the Board and working with an outside vendor to purchase and install the specialized equipment and software in OLLI's classrooms. All livestreamed programs are automatically recorded on a Vimeo channel, giving members the choice of live or later viewing.

The Ruby Gerontology Center remained closed to OLLI members and all programs were offered via Zoom until the fall semester of 2021. The first event on campus since the shut-down was the Fall Open House on August 6, 2021, which was also the first hybrid event giving members and guests the option of attending in person or online. Beginning in fall 2021, instructors were given the choice of inperson and/or online (Zoom or livestreamed). Some programs work fine online. Others require in-person interaction, and instructors of those programs were thrilled to get back on campus.

Today, hybrid works. For many of our larger, more popular classes, about one-third of attendees attend in person and two-thirds attend online. For most committees, Zoom works very well and is the mode of choice. The new normal is being driven by OLLI members' ability to choose. Online attendance is the only choice for non-ambulatory *OLLI Survived ... Continued on page 6*

85	8.10%	8.70%
90+	9.10%	9.70%

What's Happening at the Board

Following are highlights from OLLI's Board of Trustees meeting on December 8, 2022.

- Ann Sparks resigned as Treasurer for personal reasons.
 - Current membership stands at 944.
- New member registration for the spring semester started December 12.
- The Long Range Plan research by CSUF School of Business and Finance students is finished and the final report is pending. The research was in six areas: 1. Member interviews and surveys; 2. Member retention; 3. New member recruitment; 4. Website design; 5. Social media design and 6. Focus group interviews.
- OLLI's fundraising "Day of Giving" in conjunction with CSUF on March 8, 2023 is being planned by OLLI's Development/Philanthropy Committee. Last year this event resulted in \$22,000 in donations for OLLI-CSUF.
- The Nomination and Election Committee has received applications for all Board positions up for election except VP Facilities and VP Hospitality. Candidate search continues. The full election nominee slate is due January 15, and bios of all nominees will appear in the March ChroniCLE.
- Budget planning for fiscal year 2023-2024 is underway by Board officers. Final budgets will be approved on February 9.
- The Capital Plan is also underway and will be finalized by January 15.
- Revisions of OLLI Policy 6.1 on Programs and related Policy 4.1.3 on Communications to conform with current procedures were approved.
- The spring Blue Book was electronically distributed to all members on December 6. The printed version was expected to be mailed to members who requested it the week of December 12.
- A proposal to restructure the Blue Book into one Blue Book per year instead of one per semester, but extracting the class scheduling information into a separate "Schedule of Classes and Events" to be published for each semester was proposed by VP Communications Chris Shaw. A working team will address the details and obtain feedback from

instructors and coordinators. The proposal will be voted on in the February Board meeting after details and prototype documents are submitted to the Board members.

- New flooring will be installed in Shapiro ABCD from December 14 to January 12. Intersession classes scheduled in Shapiro ABCD during the intersession will be cancelled or relocated.
- Repairs to the Shapiro ABCD operable walls are planned for the spring break.
